Executive Director Hightower advised there is a problem at Woodland Park Apartments similar to the moisture problem at Gateway Housing but not as extensive. The architect is having problems getting the contractor to respond. A meeting between the attorney, architect and contractor is in process.

Commissioner White spoke with the Venice mayor and there are TIF funds that can be used to fix the sink holes at Meachum Crossing Apartments. An engineer is looking at the site.

The Section 8 Department was on the watch list in recent years for not using enough of their vouchers. HUD has notified the Housing Authority that it has reached 97% HAP utilization.

After the recently conducted audit it was shared during the exit review that 90% of the audit was complete with no findings.

Tracy Deck has accepted the Section 8 Director position.
